MORTGAGE FORECLOSURE DEED

STATE OF ALABAMA COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS: That THOMAS P. PASSEN and wife ROBERTA P. PASSEN, did, on to-wit, April 30, 1996, execute a mortgage to MortgageAmerica, Inc., which mortgage is recorded in Instrument #1996-14358, et seq., in the Office of the Judge of Probate of Shelby County; which said mortgage was subsequently assigned to NationsBanc Mortgage Corporation, n/k/a BA Mortgage LLC (A Wholly owned subsidiary of Bank of America, N.A.) Successor in interest by merger of NationsBanc Mortgage Corporation by instrument recorded in Instrument #1996-23175 of said Probate Court records; and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage and the said NationsBanc Mortgage Corporation, n/k/a BA Mortgage LLC (A Wholly owned subsidiary of Bank of America, N.A.) Successor in interest by merger of NationsBanc Mortgage Corporation did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in The Shelby County Reporter, a newspaper of general circulation published in the City of Columbiana, Shelby County, Alabama, in its issues of July 24th, 31st and August 7th, 2002; and

WHEREAS, on August 26th, 2002, the day on which the foreclosure sale was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure sale was duly and properly conducted, and did offer for sale and did sell at public outcry, in front of the Courthouse door of Shelby County, Alabama, in the City of Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of the said One Hundred Twenty Three Thousand, Three Hundred, Eighty Two dollars and no/100, in the amount of (\$123,382.00) Dollars, which sum the said NationsBanc Mortgage Corporation, n/k/a BA Mortgage LLC (A Wholly owned subsidiary of Bank of America, N.A.) Successor in interest by merger of NationsBanc Mortgage Corporation offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said BA Mortgage LLC (A Wholly owned subsidiary of Bank of America, N.A.
