

SUBORDINATION OF MORTGAGE

does hereby waive and subordinate the priority and operation of the Subordinate Mortgage upon the therein described premises to the following described mortgage ("New Mortgage"):

Mortgage to be executed by Scot Webb and Robyn Webb as Borrower, to Charter One Mortgage Corp. as Lender, securing a total indebtedness not to exceed One Hundred Ninety Four Thousand Three Hundred Dollars, (\$194,300.00), upon the above described property
