

ARTICLES OF INCORPORATION OF KIDS FIRST AWARENESS COALITION PROGRAM

I, the undersigned natural person of age, nineteen years of age or more, acting as the organizer of a non-profit corporation under the Alabama Non-Profit Corporation Act, hereby adopt the following Articles of Incorporation for the Non-Profit Corporation:

ARTICLE ONE

The name of the Non-Profit Corporation is: Kids First Awareness Coalition Program.

ARTICLE TWO

The address of the principal place of business of the Non-Profit Corporation is: 4290 Highway 52 W. Ste F, Helena, Alabama 35080.

ARTICLE THREE

The period of duration of the Non-Profit Corporation shall be perpetual from its effective date.

ARTICLE FOUR

The name and address of the Non-Profit Corporation's registered agent for service of process is: M. John Hebert, CPA, 4290 Highway 52 W. Ste F, Helena, Alabama 35080.

ARTICLE FIVE

Under the Code of the State of Alabama Section 10-3A-26, a corporation may have one or more classes of members or may have no members. If the corporation has one or more members, the designation of such a class or classes, the manner of election or appointment and the qualification and rights of the members of each class shall be set forth in the articles of incorporation or the bylaws. If the corporation has no members, that fact shall be set forth in the articles of incorporation. There shall be three board members for purposes of management and finance. The initial members of the board will be:

M. Cindy Hawkins, the primary operator of the organization, Alabaster, AL

Oscar Hawkins, Alabaster, AL

M. John Hebert, CPA, Helena, AL

The member(s) of the Non-Profit Corporation shall have the right to admit additional members, but only upon unanimous vote of all of the currently existing member(s). New members may be admitted upon any terms and conditions as the current member(s) may agree upon by unanimous vote.

ARTICLE SIX

The Non-Profit Corporation is organized for the purpose raising funds for a Non-Profit Awareness Program for children and provide an after school safe place and assistance with homework and other educational benefits and for the purposes of transacting any other lawful business for which a Non-Profit Corporation may be organized. This Non-Profit Corporation will be organized to qualify under IRC Section 501 (c) 3 of the Internal Revenue Code currently in existence.

ARTICLE SEVEN

The Non-Profit Corporation shall end upon only upon the decision of the board of directors, in which case the remaining assets of the corporation will be distributed to a similar 501(c) 3 organization or other acceptable recipient as required by the Internal Revenue Code.

ARTICLE EIGHT

The effective date of the formation of the Non-Profit Corporation shall be January 24, 2002.

ARTICLE NINE

ARTICLE TEN

The Non-Profit Corporation shall have one manager who shall serve until the first annual meeting on until his successor(s) is/(are) elected and qualified. The initial manager will be:

Any provision that is not inconsistent with the law for the regulation of the internal affairs of the corporation, including any provision for the distribution of assets on dissolution or final liquidation, may be added by a unanimous vote of the board of directors or members.
