# ARTICLES OF ORGANIZATION OF DAVID'S AUTO CLINIC, L.L.C.

The undersigned, natural persons of the age of eighteen (18) years or more, acting as organizers of Limited Liability Company under the Alabama Limited Liability Company Act, do hereby adopt the following Articles of organization for such limited liability company.

#### ARTICLE ONE

## **NAME**

The name of the limited liability company is DAVID'S AUTO CLINIC, L.L.C.

# **ARTICLE TWO**

# **DURATION**

The period of the Limited Liability Company's duration is perpetual or until expiration of the period fixed for duration of the Company from time to time, the unanimous written consent of all Members or until the earlier dissolution of the company in accordance with the provisions of the company's regulations. In the event of death or disassociation of any member, the surviving member or members shall have the right to continue the business of the company until its duration ends in accordance with this Article.

#### ARTICLE THREE

#### **PURPOSE**

This Limited Liability Company is organized for the transaction of any and all lawful business for which limited liability companies may be organized under this act.

#### ARTICLE FOUR

# REGISTERED AGENT

#### ARTICLE SIX

#### INITIAL MANAGER

The Limited Liability Company is to be managed by a manager or managers. The number of initial managers, who shall serve as managers until the first annual meeting of the members of the company or until successors are duly elected, shall be one. #### ARTICLE SEVEN

#### ADMISSION OF NEW MEMBERS

The members of the Limited Liability Company shall have the right to admit new and additional members upon such terms and conditions as are consistent with these Articles or the Operating Agreement provided said members unanimously consent.

#### ARTICLE EIGHT

## **DISSOLUTION**

The Limited Liability Company shall be dissolved upon the terms and conditions consistent with the Operating Agreement.

#### ARTICLE NINE

# MANAGER' S LIABILITY

A manager of the Limited Liability Company shall not be liable to the Limited Liability Company or its members for monetary damages for an act or omission in the manager's capacity as a manager, except that this Article Nine does not eliminate or limit the liability of a manager to the extent the manager is found liable for (i) a breach of the manager's duty of loyalty to the Limited Liability Company or it's members; (ii) an act or omission not in good faith that constitutes a breach of duty of the manager to the Limited Liability Company or an act or omission that involves intentional misconduct or a knowing violation of the law; (iii) a transaction from which the manager received an improper benefit whether or not the benefit resulted from an action taken within the scope of the manager's office; or (iv) an act or omission for which the liability of a manager is expressly provided by an applicable statute. Any repeal or amendment of this Article Nine by the members of the Limited Liability Company shall be prospective only and shall not adversely affect any limitation on the liability of a manager of the Limited Liability Company existing at the time of such repeal of amendment.
