


CERTIFICATE OF OATH





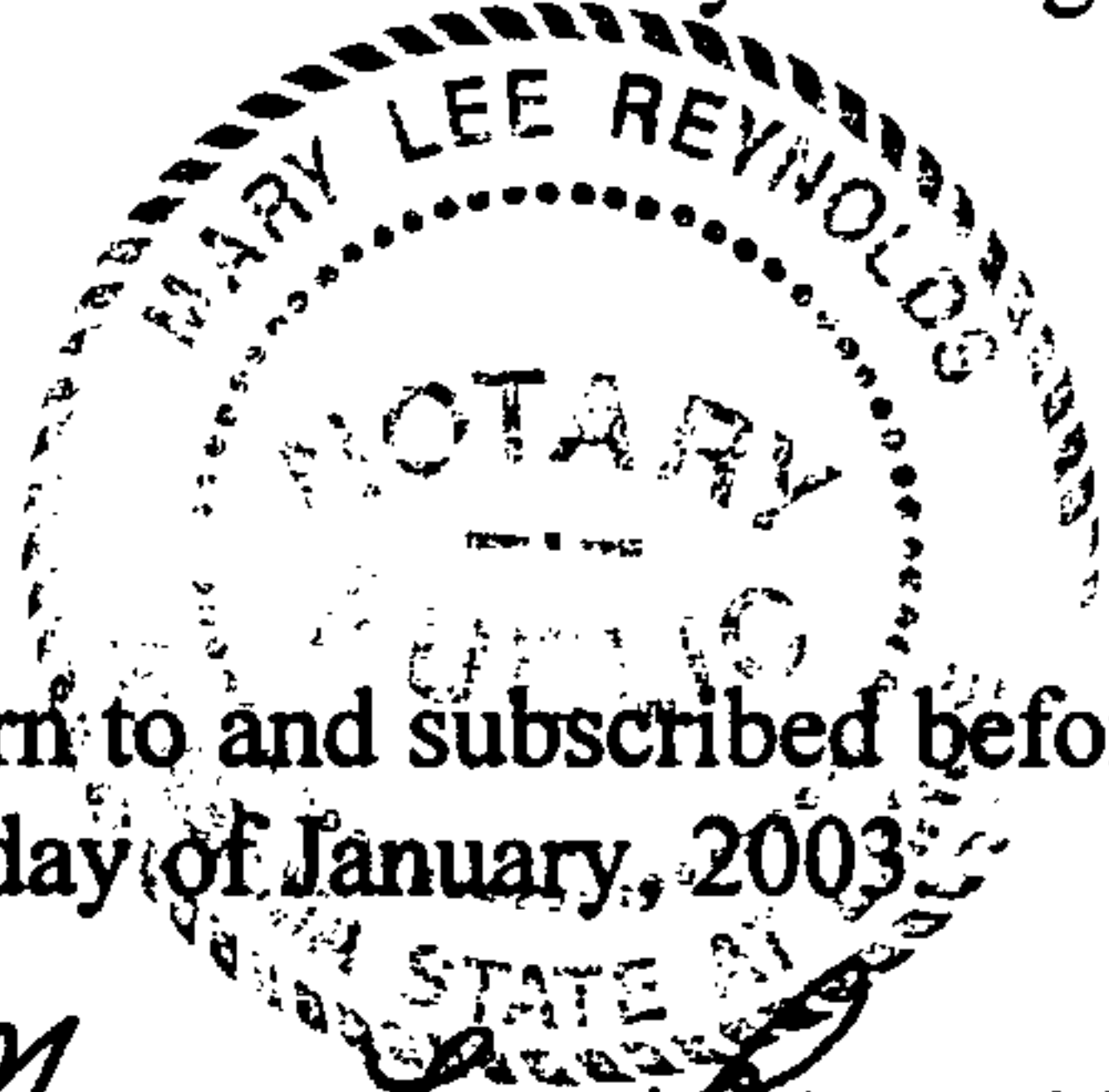
