KNOW ALL MEN BY THESE PRESENTS, that in consideration of \$500.00 and other valuable considerations to the undersigned GRANTOR or GRANTORS in hand paid by the GRANTEE(S) herein, the receipt whereof, is hereby acknowledged I/we, **KENDALL RYAN PUCKETT and ANGELA PUCKETT, HUSBAND AND WIFE,** (herein referred to as GRANTOR(S), do hereby GRANT, BARGAIN, SELL and CONVEY unto **KENDALL RYAN PUCKETT and ANGELA PUCKETT, HUSBAND AND WIFE,** (herein referred to as GRANTEE(S)for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in the **County of SHELBY, and State of Alabama,** to-wit:

The purpose of this deed is to add wife to title.



Subject to easements, restrictive covenants and ad valorem taxes of record.


