# ARTICLES OF ORGANIZATION OF HIGH MIX PRODUCTIONS, L.L.C.

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, desiring to form a Limited Liability Company under the laws of the State of Alabama, do hereby adopt the following Articles of Organization:

## ARTICLE I NAME

The name of the Limited Liability Company shall be HIGH MIX PRODUCTIONS, L.L.C. (the Company").

### ARTICLE II PERIOD OF DURATION

The term for which the Company is to exist as a Limited Liability Company shall commence on the date these Articles of Organization are filed in the Office of the Judge of Probate of Jefferson County, Alabama, and shall continue until the Company shall be dissolved: (a) upon the written consent of all of the Members; (b) as provided in the Operating Agreement; (c) as may be required by the Alabama Limited Liability Company Act, as the same may be amended from time to time; or (d) by any other act or event specified by law as one effecting dissolution.

# ARTICLE III PURPOSE

The Company is formed to transact any and all lawful business for which a Limited Liability Company made be organized under the Alabama Limited Liability Company Act, including, but not limited to:

(a) To engage in the financing, production, and selling of live entertainment; and to broadcast, disseminate, distribute, transmit, retransmit, receive, or collect by electrical, electronic, or any other means, music, entertainment, news, speeches, sermons, advertising, educational and

informative matter, photographs, pictures, scenes, or plays, and to provide for the use of other facilities for such purposes;

- (b) Acquiring, owning, operating, managing, leasing, mortgaging, encumbering, selling, exchanging, otherwise disposing of and/or dealing with businesses and investments for the production of income and profit;
- (c) Acquiring, owning, operating, managing, mortgaging, encumbering, selling, exchanging, repairing, leasing and developing of real and personal property;
- (d) Acquiring, owning, buying, selling, investing in, managing, financing, refinancing, exchanging, otherwise disposing of and/or dealing with stocks, securities, partnership interests, limited liability company interests, certificates of deposit, mutual funds, commodities, and any and all whatsoever, that the Managers may from time to time deem to be in the best interests of the Company; and
- (e) Engaging in any and all activities related or incidental to the foregoing business of the Company.

# ARTICLE IV LOCATION OF REGISTERED OFFICE AND NAME OF REGISTERED AGENT

The initial registered office of the Company shall be at 4905 Whispering Lake Circle, Birmingham, AL 35244, and the name of the initial registered agent at such address shall be Naseem Ajlouny.

The Members and the Managers of the Company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the Company.
