

## SUBORDINATION AGREEMENT

Pursuant to the terms of the mortgage entered into by and between <u>Craig Brashier</u> and <u>Kimberly L. McMillican</u> to <u>National Bank of Commerce of Birmingham</u> on <u>May 30</u>, 2002 and recorded in <u>Instrument #20020606000265640</u> in the Probate Office of <u>Shelby</u> County, Alabama.
