

**PARTIAL RELEASE**

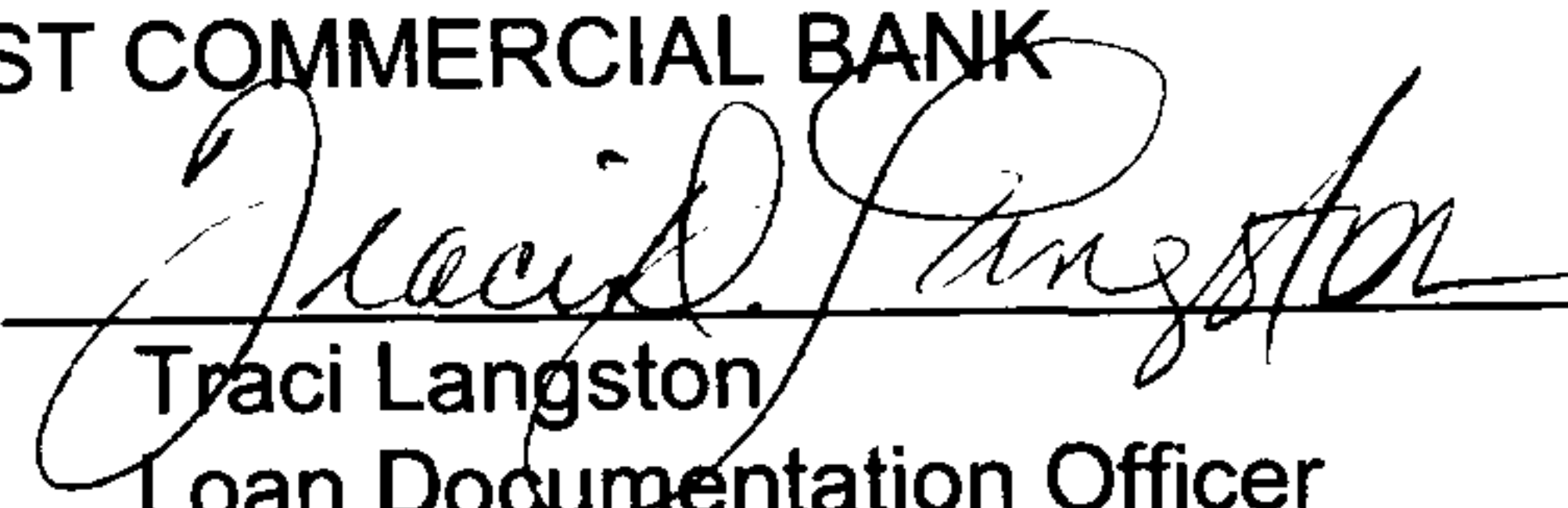
