

PARCEL I:

Following is a description of a tract of land known as Tract 4 of the Jerry McGaha Property situated in the South $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of Section 33, Township 17 South, Range 1 East, Shelby County, Alabama; being more particularly described as follows:

Commence at an iron pin found, locally accepted to be the Northeast corner of the Southeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 33, Township 17 South, Range 1 East and run thence North $89^{\circ}25'30''$ West along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 162.57 feet to an iron pin found on the Southerly right of way of Shelby County Highway #101; thence South $60^{\circ}10'40''$ West along said right of way a distance of 61.88 feet to a concrete monument found at a point of curvature; thence Southwesterly along the arc of a curve and said right of way a distance of 315.05 feet to the point of beginning of the within described tract; said curve having a radius of 1950.46 feet, a central angle of $09^{\circ}15'17''$, a chord bearing of South $84^{\circ}50'37''$ West and a chord distance of 314.70 feet; thence South $16^{\circ}48'18''$ East a distance of 257.38 feet to the center of a creek; thence South $58^{\circ}33'00''$ West along the center of said creek a distance of 134.27 feet; thence North $16^{\circ}48'19''$ West a distance of 287.22 feet to the Southerly right of way line of said Shelby County Highway #101 and a point of curvature; thence Northeasterly along the arc of said curve and said right of way a distance of 130.00 feet back to the point of beginning, said curve having a radius of 1950.46 feet, a central angle of $03^{\circ}49'08''$, a chord bearing of North $71^{\circ}22'49''$ East and a chord distance of 129.98 feet.

PARCEL II:

Following is a description of a tract of land known as Tract 5 of the Jerry McGaha Property situated in the South $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of Section 33, Township 17 South, Range 1 East, Shelby County, Alabama; being more particularly described as follows:

Commence at an iron pin found, locally accepted to be the Northeast corner of the Southeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 33, Township 17 South, Range 1 East and run thence North $89^{\circ}25'30''$ West along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 162.57 feet; to an iron pin found on the Southerly right of way of Shelby County Highway #101; thence South $60^{\circ}10'40''$ West along said right of way a distance of 61.88 feet to a concrete monument found at a point of curvature; thence Southwesterly along the arc of a curve and said right of way a distance of 445.05 feet to the point of beginning of the within described tract; said curve having a radius of 1550.46 feet, a central angle of $13^{\circ}04'25''$, a chord bearing of South $66^{\circ}45'10''$ West and a chord distance of 444.08 feet; thence South $16^{\circ}48'19''$ East a distance of 257.22 feet to the center of a creek; thence South $77^{\circ}05'48''$ West along the center of said creek a distance of 105.05 feet; thence continue along the center of said creek North $63^{\circ}00'15''$ West a distance of 27.64 feet; thence North $15^{\circ}48'19''$ West a distance of 265.01 feet to the Southerly right of way line of said Shelby County Highway #101 and a point of curvature; thence Northeasterly along the arc of said curve and said right of way a distance of 125.00 feet back to the point of beginning; said curve having a radius of 1950.46 feet, a central angle of $03^{\circ}40'19''$, a chord bearing of North $75^{\circ}07'32''$ East and a chord distance of 124.98 feet.
