KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Seventy-One Thousand Five Hundred Fifty-One and 16/100 (\$171,551.16) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Denman Builders, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Kevin B. Allen and Kristi M. Allen, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

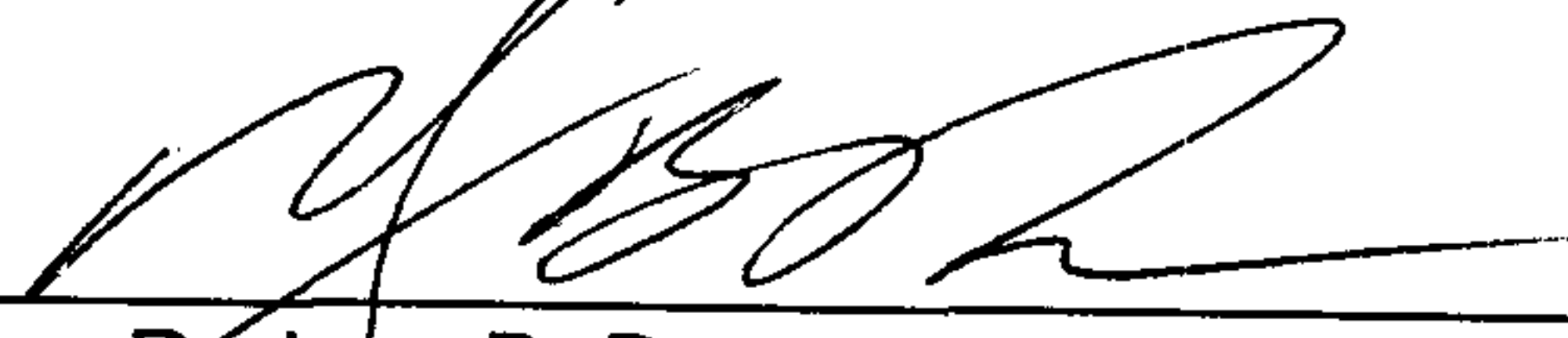
\$137,200.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

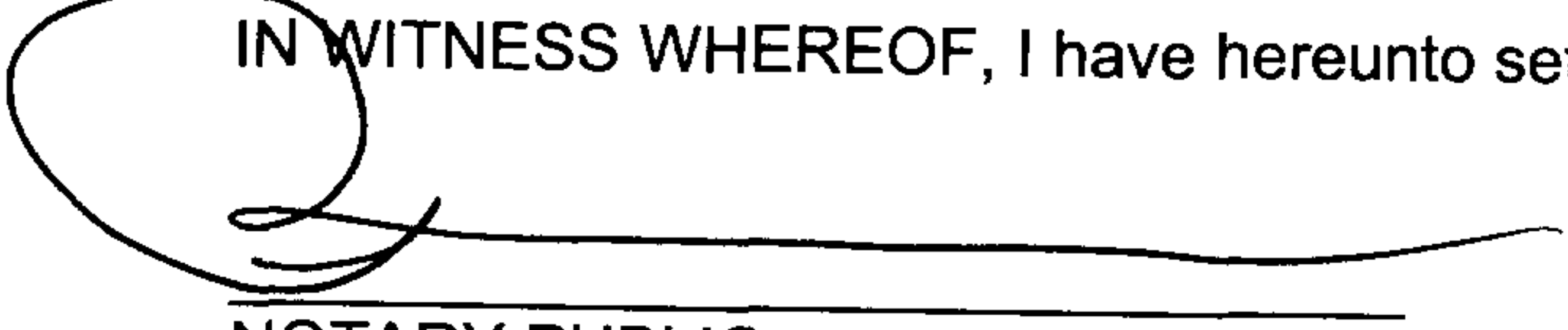
