THIS FORECLOSURE DEED made this 18th day of November, 2003, between KEITH H. HARTMAN and wife, AMY L. HARTMAN, Parties of the First Part, and CHASE MANHATTAN MORTGAGE CORPORATION, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said KEITH H. HARTMAN and wife, AMY L. HARTMAN, heretofore executed to MORTGAGEAMERICA, INC., herein called the Mortgagee, a certain mortgage dated October 29, 1999, and recorded in Instrument No. 1999-45214, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and the Party of the Second Part thereafter gave notice by publication in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on the 1st day of October, 2003, the 8th day of October, 2003, and the 15th day of October, 2003, that it would sell the hereinafter described property before the front door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on the 18th day of November, 2003; and


