2. Easements, rights-of-way, restrictions, conditions and covenants of record.

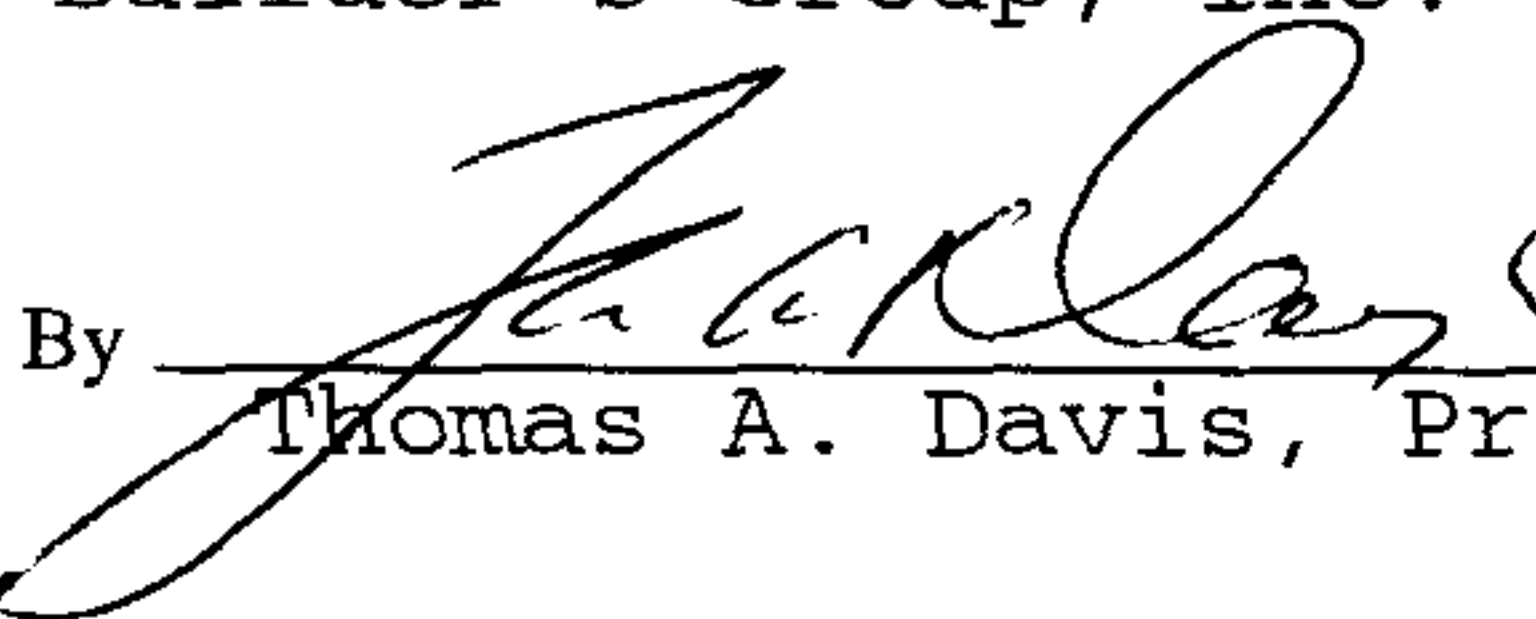

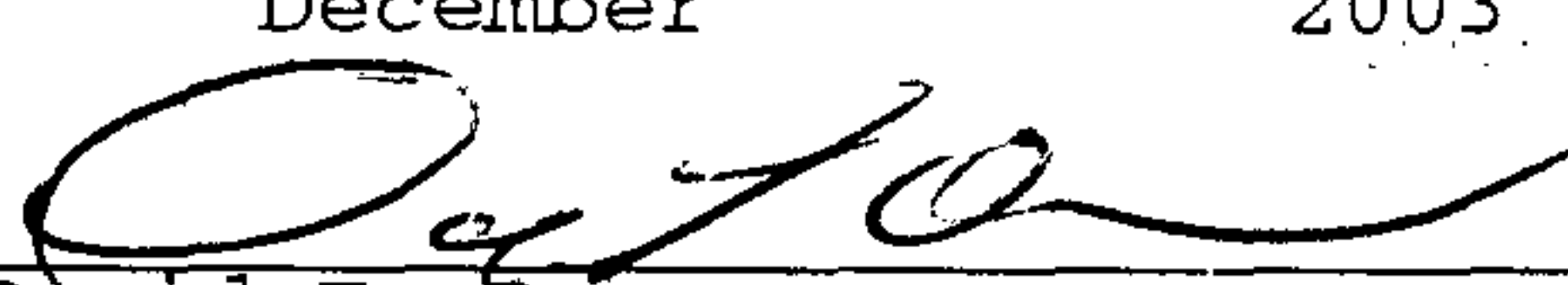
