MORTGAGE MODIFICATION AGREEMENT

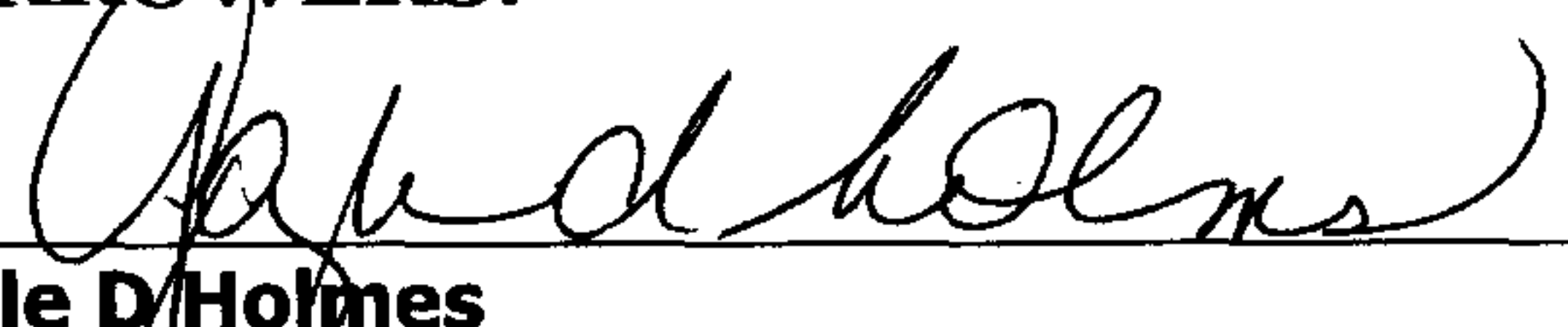

****Gayle D Holmes is one and the same person as Gayle White.**

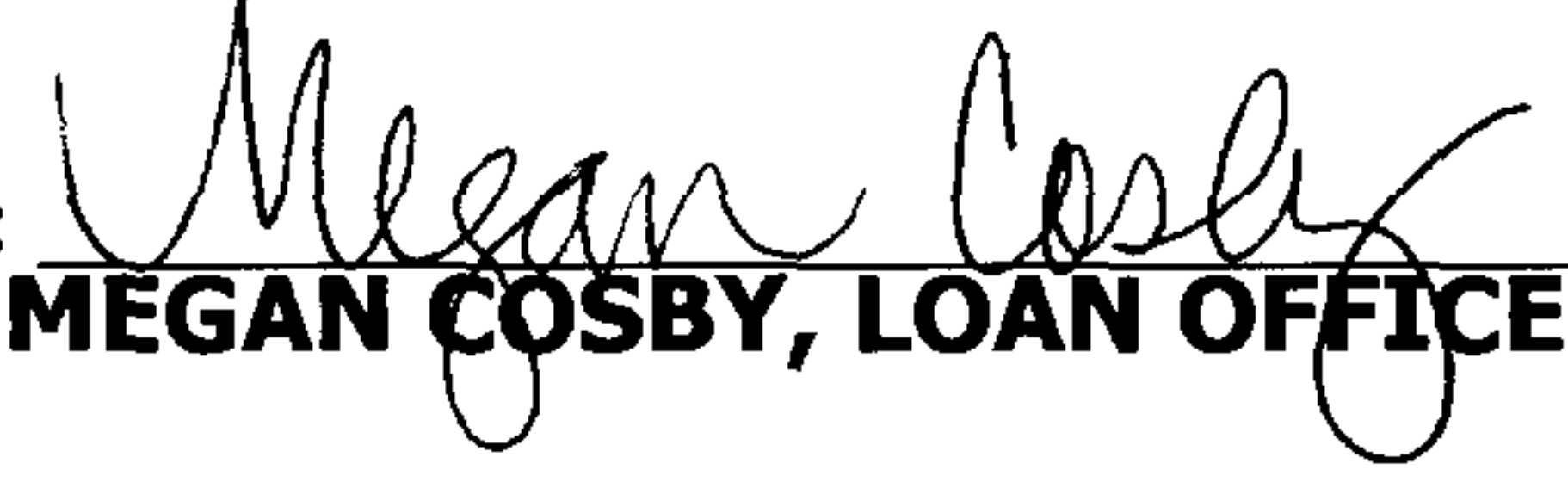
Except as modified herein, all of the terms and conditions of the Mortgage shall remain in full force and effect.

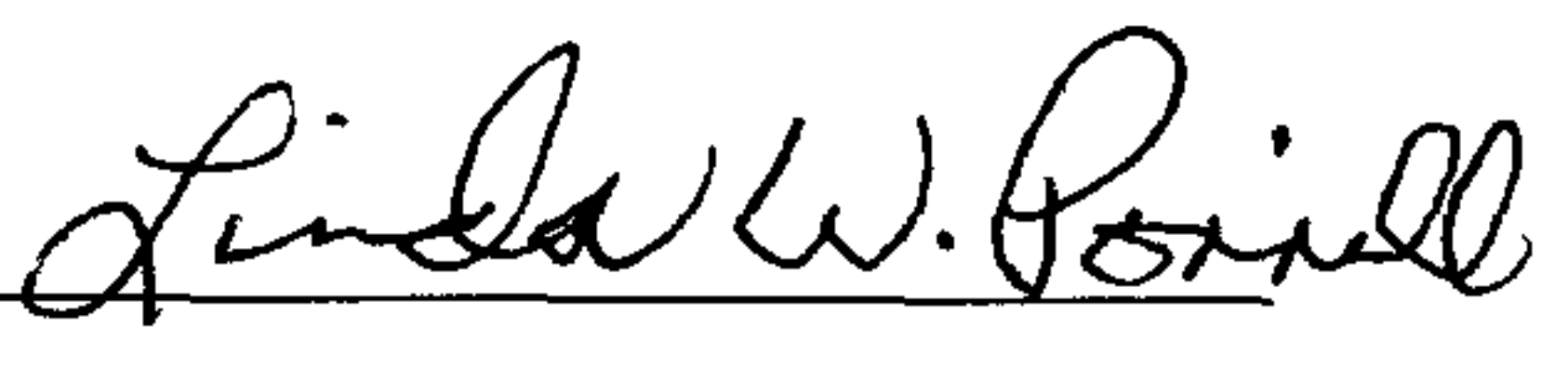
