KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Fifty-Four Thousand Nine Hundred and 00/100 (\$154,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Professional Homebuilders, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Kenneth C. THIS DEED IS BEING RE-RECORDED TO CORRECT THE GRANTEE WIFE NAME.

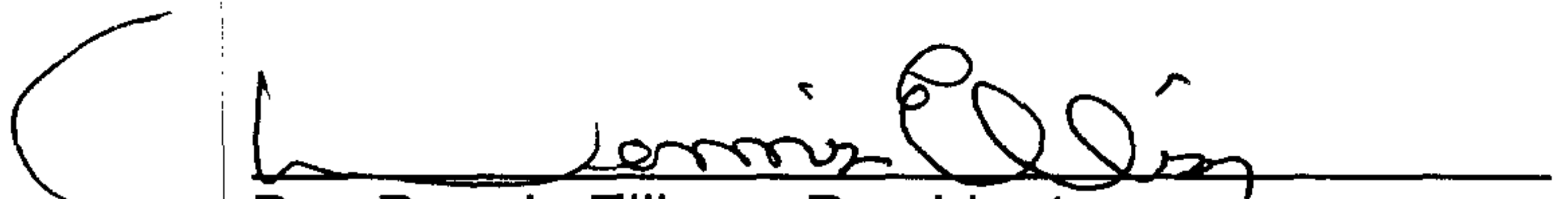
Professional Homebuilders, Inc. and Professional Home Builders, Inc. are one and the same entity.
