**ARTICLES OF ORGANIZATION
OF
CHECK CONNECTION OF LEEDS, L.L.C.**

The undersigned, desiring to form a Limited Liability Company pursuant to Section 10-12-1, et seq. of the Code of Alabama, hereby adopts the following Articles of Organization:

1. The name of the Limited Liability Company is **CHECK CONNECTION OF LEEDS, L.L.C.**

2. The existence of the Limited Liability Company shall commence on the date of the filing of the Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetuity, provided however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of the Members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.

3. The purpose for which this Limited Liability Company is organized is:

(a) To provide a check cashing, deferred presentment, and title loan service.

(b) To engage in the transaction of any or all other lawful business for which Limited Liability Companies may be organized under the laws of the State of Alabama.

The Members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member of the Limited Liability Company if there are remaining Members and if the legal existence and business of the Limited Liability Company is continued by a written consent of all the remaining Members within ninety (90) days after the occurrence of the event of dissociation.
