## SUBORDINATION AGREEMENT

WHEREAS, Michael Wayne Lillie and Lisa Fortner Lillie (hereinafter referred to as "Borrowers"), have applied to AmPro Mortgage Corporation (hereinafter referred to as "Bank") for a loan of money in the amount of \$317,000.00 to be secured by a mortgage on the property hereinafter described; and
