**ARTICLES OF ORGANIZATION
OF
VENTURE DEVELOPERS, LLC**

Pursuant to the Provisions of Sections 10-12-1, *et seq.*, of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I
Name

The name of the limited liability company is VENTURE DEVELOPERS, LLC (the "Company").

ARTICLE II
Duration

The Company shall have a duration from the date of organization until the fiftieth anniversary of the filing of these Article in the Probate Office of Shelby County, Alabama, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III
Purposes

The purposes for which the Company is formed are:

- (a) To purchase, develop and sell real estate; and
- (b) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV
Registered Office; Registered Agent

The cessation of membership of one or more members will not result in the dissolution of the Company.


ARTICLE VIII
