## SPECIFIC DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: that I, SAMANTHA DYANE CHARIF, as Principal (hereinafter referred to as "Principal"), a resident of SHELBY COUNTY, ALABAMA, hereby make, constitute and appoint my husband, SAMER CHARIF, of SHELBY COUNTY, ALABAMA, as my true and lawful agent and attorney in fact (hereinafter referred to as "Attorney") with all the rights, powers, and authority extended herein being bestowed upon Attorney immediately upon my execution of this instrument for the purposes stated herein, with said rights, powers, and authority surviving any period of my disability, incompetency, and/or incapacity remaining in full force and effect until such time that I, as Principal, revoke the same in writing and Attorney actually receives said revocation. Attorney is hereby duly authorized and empowered to do and perform each and every act as specified below:

Third parties may rely upon the representation of Attorney as to all matters relating to any power granted thereto, and no person acting in reliance upon the representation of Attorney as to the authority granted them shall incur any liability to me or my estate as a result of permitting Attorney to exercise any power. Attorney shall be entitled to reimbursement for all reasonable costs and expenses incurred and paid by Attorney on my behalf pursuant to any provisions of this Specific Durable Power of Attorney, but Attorney shall not be entitled to compensation for services rendered hereunder, except by separate contract.

Notwithstanding any provision herein to the contrary, this Specific Durable Power of Attorney shall not be construed as being intended for any legal purposes other than those specified hereunder.

Throughout this instrument, the term "Attorney" shall be construed as either singular or plural, as appropriate; likewise, the terms "him" and "his" shall be construed as masculine, feminine, or neutral, as applicable.
