THIS FORECLOSURE DEED made this the 8th day of June, 2004, between ALLEN A. ENGLISH and DARLENE ENGLISH, a married couple, Parties of the First Part, and CONSECO FINANCE CORP.-ALABAMA N/K/A GREEN TREE-AL LLC, Party of the Second Part;

WITNESSETH:

WHEREAS, the said ALLEN A. ENGLISH and DARLENE ENGLISH, a married couple heretofore executed to CONSECO FINANCE CORP.-ALABAMA herein called the Mortgagee, a certain mortgage dated December 6, 2000, and recorded in Instrument Number 2000-45496, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and the Party of the Second Part was owner thereof at the time of the sale hereinafter mentioned; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and the Party of the Second Part thereafter gave notice by publication in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on the 28th day of April, 2004, the 5th day of May, 2004 and the 12th day of May, 2004, that it would sell the hereinafter described property before the front door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on the 8th day of June, 2004, and

WHEREAS, the said sale was held at the time and place stated in said notice which was published in the said issues of The Shelby County Reporter, and Party of the Second Part became the purchaser of the hereinafter described property at and for the sum of \$76,263.75 cash, which was the highest, best, and last bid therefor; and

WHEREAS, the undersigned, JAMES J. ODOM, JR., conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by the Party of the Second Part;



Commence at the SW corner NW ¼, SE ¼, Section 24, Township 21 South, Range 1 West, run South 00 degrees 58 minutes 59 seconds West for a distance of 84.41 feet; thence run South 77 degrees 56 minutes 48 seconds East for a distance of 120.36 feet to the point of beginning; thence continue South 77 degrees 56 minutes 48 seconds East for a distance of 181.26 feet to the West right of way line of Highway No. 25; thence run North 19 degrees 12 minutes East along Highway Right of Way for a distance of 175.85 feet; thence run North 44 degrees 59 minutes West for a distance of 116.0 feet; thence run North 89 degrees 05 minutes West for a distance of 127.6 feet; thence run South 06 degrees 51 minutes West for a distance of 213.84 feet to the point of beginning.
