IN CONSIDERATION THESE PRESENTS ALL MEN BY KNOW Fifteen Thousand Five Hundred Forty and 91/100 Dollars. the undersigned grantor, Odell Higgins and Frances W. Higgins (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto Deborah K. Higgins Young and Barry Glenn Young (herein referred to as grantee, whether one or more), as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama:

All that part of the SE 1/4 of Section 15, Township 22, Range 1 West, lying S of the Shelby-Calera public road, containing 17 acres, more or less.
