For One Hundred and no/100 (\$100.00) Dollars and other good and valuable considerations to the undersigned paid by the Grantee herein, the receipt of which is hereby acknowledged, the undersigned, Peoples Southern Bank, a state banking corporation, hereinafter called "Grantor", has granted, bargained and sold, and does by these presents, GRANT, BARGAIN, SELL and CONVEY unto John Thomas Boykin, III, a married man, and Patricia Boykin Cox, a married woman, joint with right of survivorship, the following described property situated in the county of Shelby, State of Alabama, to-wit:

Lot 5, according to Map of "Rice Acres, Sector Two" as recorded in the Probate Office of Shelby County, Alabama in Map Book 5, Page 87. LESS AND EXCEPT caption lands recorded in Deed Book 332, Page 064 in Probate Office of Shelby County, Alabama.
