**DURABLE POWER OF ATTORNEY
(Specific and Limited)**

This power of attorney shall not be effected by disability, incompetence, or incapacity of the principals in accordance with Alabama Code Section 26-1-2 (1975).

1. **APPOINTMENT OF ATTORNEY IN FACT.** I **Charlie James Jameson**, Principal ("Principal"), resident of the State and county aforesaid, has made, constituted and by these presents to make constitute and appoint **Sandra S. Jameson** as my true and lawful agent and attorney-in-fact ("Agent") to do and perform the following:

To do any and all acts, to take any actions and execute any documents in connection with the sale of the property described as:

Lot 14. According to the Survey of Phase I Wynlake Subdivision, as recorded in Map Book 19, page 156, in the Probate Office of Shelby County, Alabama.

To do any and all acts, to take any actions and execute any documents in connection with the sale of the property located at **307 Wynlake Circle, Alabaster, AL 35007**, including signing all loan documents, settlement statement or other related documents as I may do in my on stead. This Power of Attorney shall be valid and of full force and effect for forty-five (45) days from the date of execution of this Power of Attorney.

2. **EXECUTION AND DELIVERY.** The execution and delivery by Agent of any check, draft, conveyance, paper, deed, instrument or document in my name and behalf shall be conclusive evidence of Agent's approval of the consideration therefore, and of the form and contents thereof, and that Agent deems the execution thereof in my behalf necessary and desirable.



5. **EFFECTIVE DATE OF AGENT'S AUTHORITY.** This specific and limited Durable Power of Attorney shall become effective upon its execution by the Principal and delivery to the Agent.


