

## DURABLE POWER OF ATTORNEY (Specific and Limited)

This power of attorney shall not be effected by disability, incompetency, or incapacity of the principals in accordance with Alahama Code Section 26-1-2 (1975).

APPOINTMENT OF ATTORNEY IN FACT. I Trevar O. Chapmon, principal ("Principal"), resident of the State and County aforesaid, has made, constituted and by these presents to make, constitute and appoint Ginger H. Sova as my true and lawful agent and attorney-in-fact ("Agent") to do said perform the following:

To do any and all acts, to take any actions and execute any documents in connection with the sale of the property described as:

- 5. EFFECTIVE DATE OF AGENT'S AUTHORITY. This Specific and Limited Durable Power of Attorney shall become effective upon its execution by the Principal and delivery to the Agent.
