
ARTICLES OF INCORPORATION OF

TO THE HONORABLE JUDGE OF PROBATE OF JEFFERSON COUNTY, ALABAMA:

The undersigned, Michael R. O'Donnell, acting as incorporator of a corporation under the provisions of the Code of Alabama, Section 10-2B-2.01, et al., adopts the following Articles of Incorporation for the Corporation:

- 1. The name of the Corporation is Catered to You, Inc., and the Corporation is authorized to operate under that name or use any other trade name.
- 2. The Corporation is formed to cater food and beverages, and to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama.
