**ARTICLES OF ORGANIZATION
of
EMERALD RIDGE, LLC**

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is EMERALD RIDGE, LLC.
2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Jefferson County, Alabama, and shall continue until December 31, 2050, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. The purpose for which this Limited Liability Company is organized is to develop and sell residential lots in a subdivision to be known as Emerald Ridge and to engage in all other business permitted under the laws of the State of Alabama.
4. The location and mailing address of the initial registered office shall be 1974 Chandalar Drive, Pelham, Alabama 35124, and the name of the initial registered agent at said address shall be Karen B. Scott.
