THIS SUPPLEMENTAL AGREEMENT made this 11th day of May, 2004 between Alabama Power Company, a corporation, hereinafter called the Power Company and Southern Natural Gas Company (successor to Southern Natural Gas Corporation), a corporation, hereinafter called the Gas Company;

WITNESSETH:

WHEREAS, there is in effect between the parties hereto, a certain agreement dated the 4th day of October, 1930, by which the Power Company has the right to construct, operate and maintain electric power lines over, under and across the rights of way and easements of the Gas Company; WHEREAS, the Power Company desires the right to construct, operate and maintain a power line over, under and across the rights of way of the Gas Company at the following locations:

At a point in the SE ¼ of NW 1/4, Section 25, Township 21 South, Range 3 West, Shelby County, Alabama and shown marked in yellow on Exhibit "A", sheets 1 & 2 of 2, attached hereto and made a part hereof.

NOW THEREFORE, in consideration of the premises and of their mutual covenants and agreements, the parties hereto have mutually covenanted and agreed as follows: The Gas Company hereby grants to the Power Company, insofar as the Gas Company has any right or title to make such grant, the right to construct, operate and maintain the power line crossing as shown on the print hereto attached and marked Exhibit "A" but subject, however, to all the terms and conditions of the aforesaid agreement dated October 4, 1930, and the parties agree that all and singular provisions of said agreement shall apply to the transmission and distribution line crossing herein described, the same manner and to the same extent as though such crossing had been included in the said agreement.


