Commence at the Northeast corner of the NW ¼- NW ¼, Section 22, Township 20 South, Range 3 West, Shelby County, Alabama, and run thence N 89°50′44″ W along the North line of said ¼-¼, 671.75′ to a point, thence run \$ 57°50′40″ E a distance of 97.06′ to a point on the West right of way line of a 60.0′ wide public road and the point of beginning of the property being described, thence run \$ 33°40′58″ W along the said right of way line of Highway 261 (Main Street) a distance of 119.16′ to a point, thence run N 54°00′48″ W a distance of 10.02′ to an existing concrete monument marking the change to an 80.0′ wide public road, thence run \$ 47°37′55″ W a distance of 2.12′ to a point, thence run N 38°18′48″ W a distance of 144.07′ to a point, thence run \$ 55°45′08″ W a distance of 74.08′ to a point on the East right of way line of a 30.0′ wide public road, thence run N 0°44′29″ E along said right of way line a distance of 164.28′ to a point, thence run S 57°50′44″ W a distance of 264.80′ to the point of beginning.
