

## ARTICLES OF INCORPORATION OF THE PAMPERED PET RESORT, INC.

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

- 1. Name. The name of the corporation is THE PAMPERED PET RESORT, INC.
- 2. <u>Authorized Shares</u>. The number of shares the corporation is authorized to issue is One Hundred (100). All shares shall be of the same class and shall be designated as Common Stock.
- 3. Registered Office and Registered Agent. The street address of the corporation's initial registered office is 110 Sunset Lane, Calera, Alabama 35040. The corporation's initial registered office is located in Shelby County, Alabama. The name of the corporation's registered agent at that office is Stephanie Louise Clayton.

- 6. <u>Purpose or Purposes</u>. The purpose or purposes for which the corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act, including, but not limited to, the following:
  - (a) To engage in the business of operating a pet boarding facility or facilities.
- (b) To invest in real estate, mortgages, stocks, bonds, promissory notes or any other type of investment.
- (c) To own or lease real or personal property necessary or appropriate in the conduct of its business.

## 7. Other Provisions.

- (a) Par Value. The par value of each authorized share is \$1.00.
- (b) <u>Limitation of Liability</u>. A director of the corporation shall not be liable to the corporation or its shareholders for money damages for any action taken, or any failure to take any action, as a director, except liability for (A) the amount of a financial benefit received by a director to which he or she is not entitled; (B) an intentional infliction of harm on the corporation or the shareholders; (C) a violation of Section 10-2B-8.33 of the Alabama Business Corporation Act; (D) an intentional violation of criminal law; or (E) a breach of the director's duty of loyalty to the corporation or its shareholders.
