

ARTICLES OF INCORPORATION

OF

(Pursuant to the provisions of the Alabama Business Corporation Act)

The undersigned person has associated themselves for the purpose of forming a corporation under the laws of Alabama and adopts the following Articles of Incorporation.

1. **Name.** The name of this corporation is LP Outdoor Recreation, Inc. The period of duration shall be perpetual.
2. **Purpose and Powers.** The purpose of the corporation is for the sales and service of outdoor equipment and to engage in any lawful act or activity for which a corporation may be organized under the laws of Alabama other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Alabama Statutes.
