KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Fifty-Nine Thousand Nine Hundred and 00/100 (\$259,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Willoughby Development, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Robert C. Weidler and Leslie G. Weidler**, (hereinafter referred to as GRANTEE), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 20, according to the Survey of Fieldstone Park 4th Sector, as recorded in Map Book 30 page 107 and re filed in Map Book 31 page 3 in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama. Mineral and mining rights excepted.

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

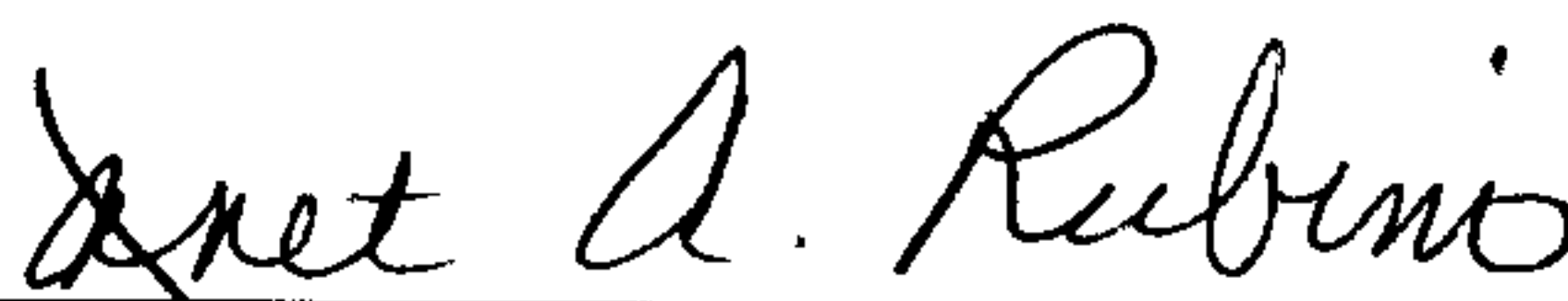
\$207,900.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

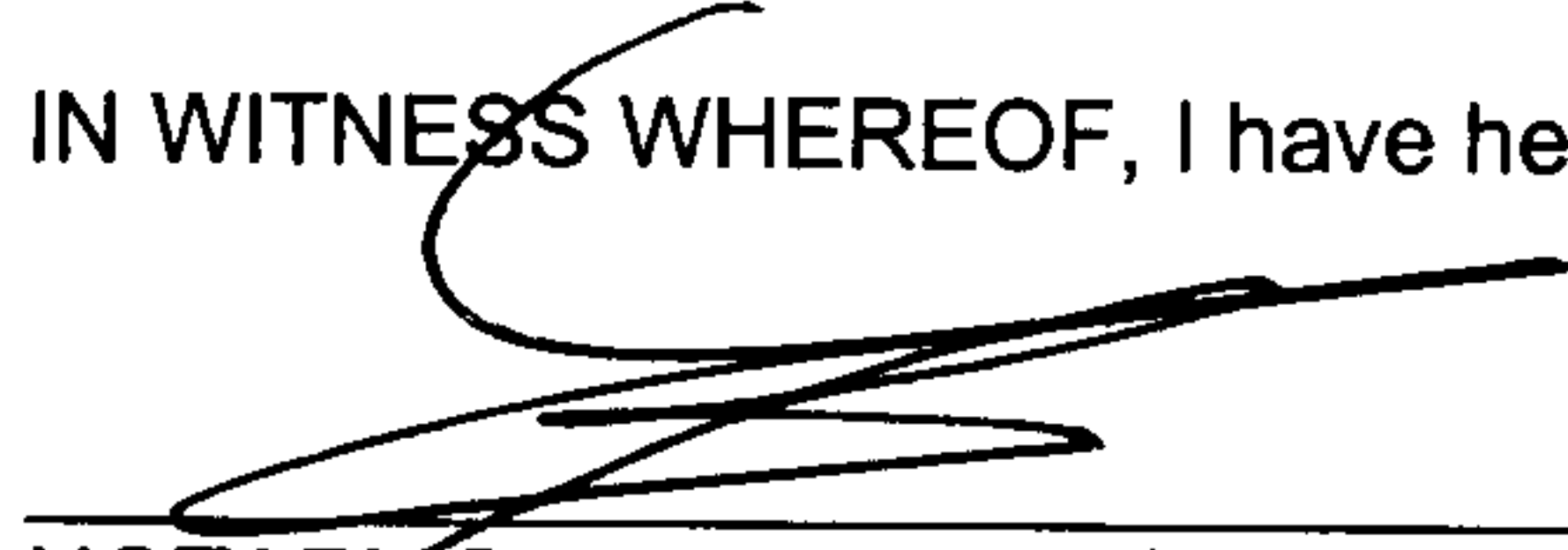
