

ARTICLES OF INCORPORATION

OF

GLENN HOSEY AUTOMOTIVE, INC.

The undersigned, acting as incorporator of a corporation under the Code of Alabama, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GLENN HOSEY AUTOMOTIVE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To engage in the business of wholesale automobile sales;
- (b) To engage in the transaction of any and all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act.

FOURTH: The location and mailing address of the initial registered office, and the name of the initial registered agent at such address of the corporation is:
