TO THE HONORABLE JUDGE OF PROBATE
OF SHELBY COUNTY, ALABAMA:

I, the undersigned, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act"), as amended, do hereby certify as follows:

1. NAME. The name of the limited liability company (the "Company") is:

Black Family, LLC

2. DURATION. The Company shall have perpetual duration.

3. PURPOSES. The purposes for which the Company is organized are:

(a) To make investments.

(b) To carry on any other business in connection with the foregoing, to transact any and all lawful business for which limited liability companies may be organized under the Act, as amended from time to time, and to have and exercise all powers necessary or convenient to effectuate the purposes of the Company.

(c) To do any and all of the things herein set out and such other things as are incidental or conducive to the attainment of the objectives and purposes of the Company, to the same extent as natural persons might or could do and in any part of the world, as principal, factor, agent, contractor, or otherwise, either alone or in conjunction with any person, firm, association, partnership, corporation, association, limited liability company, limited partnership, cooperative or any other entity of any kind whatsoever, and to have and exercise any and all such powers to the full extent authorized or permitted to a limited liability company under any laws that may now or hereafter be applicable or available to the Company.

The foregoing subsections shall be construed, in the broadest sense, as purposes and powers of the Company in addition to those powers specifically conferred upon the Company by law, and it is hereby expressly provided that the foregoing specific enumeration of purposes and powers shall not be held to limit or restrict in any manner the purposes and powers of the Company otherwise granted by law. Nothing

herein contained, however, shall be construed as authorizing the Company to carry on the business of banking, of a trust company, or of insurance.

4. INITIAL REGISTERED OFFICE AND AGENT. The location and mailing address of the initial registered office of the Company, and the name of its initial registered agent at such address, is as follows:

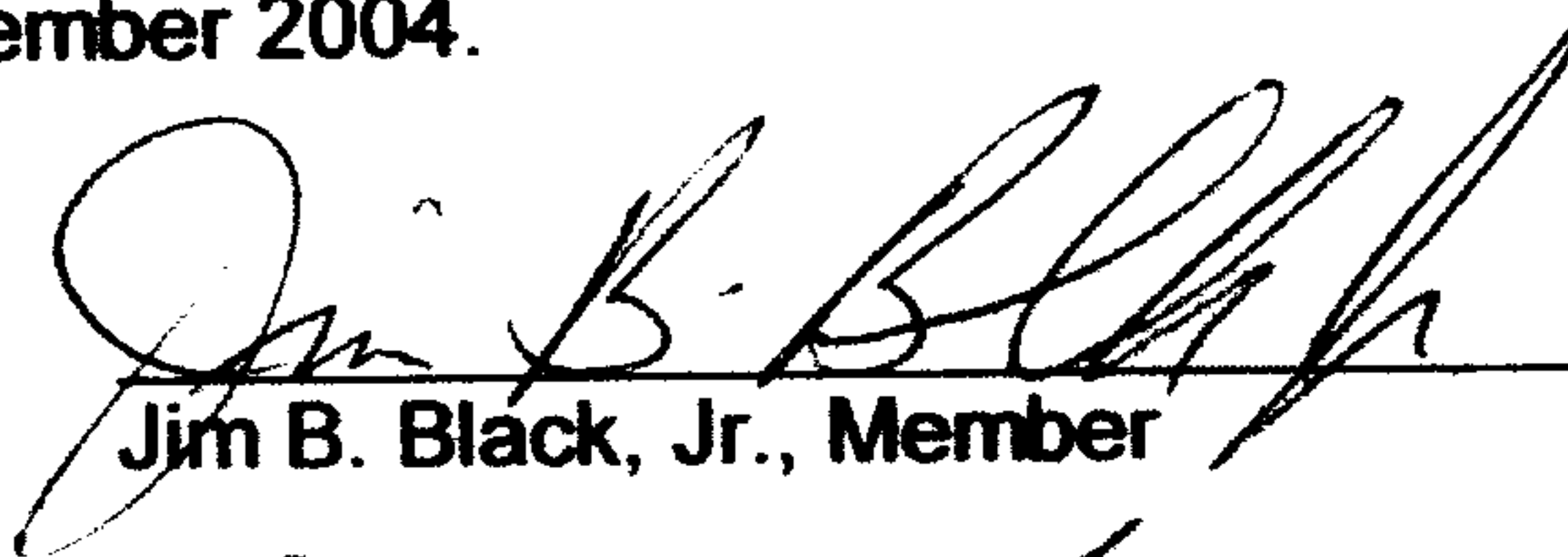

6. ADDITIONAL MEMBERS. The members of the Company shall have the right to admit additional members in the manner provided in the Company's operating agreement, as amended from time to time.

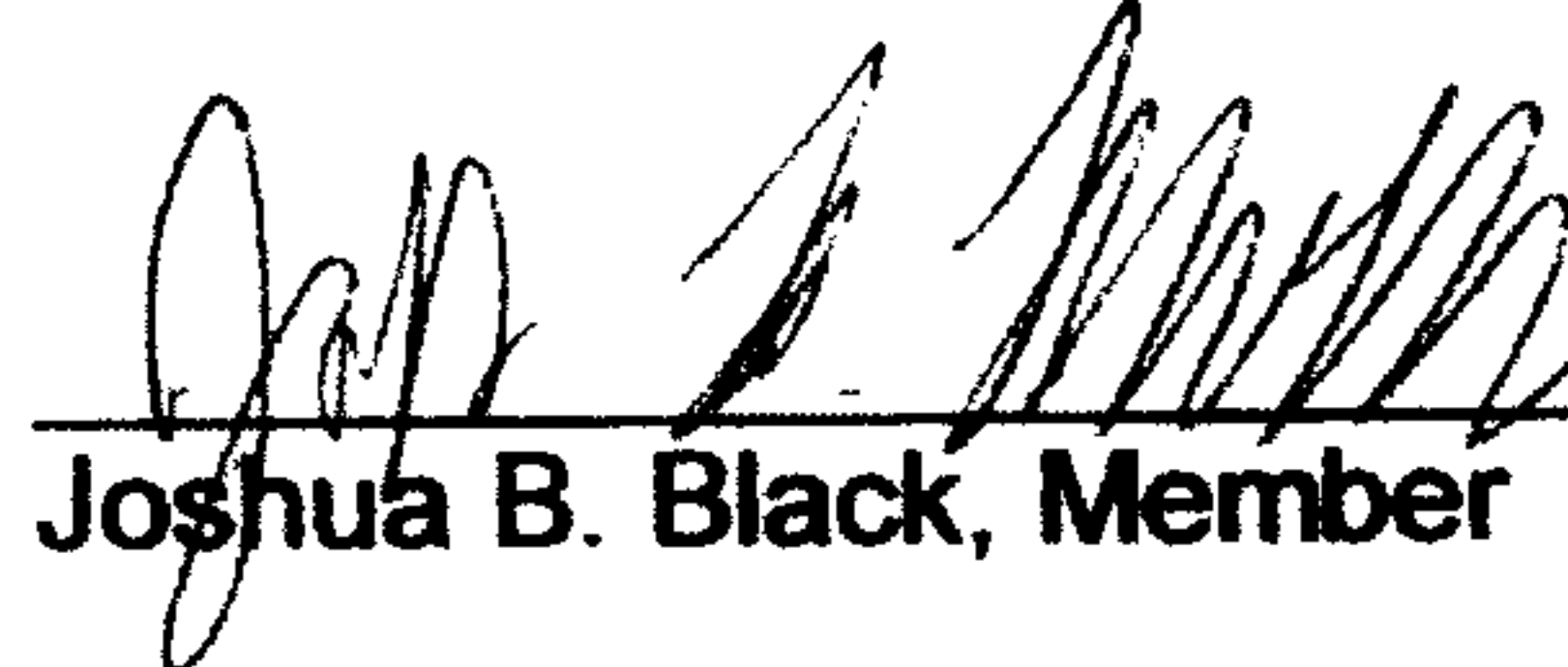
7. MANAGEMENT. A manager or managers will manage the Company. The initial manager shall be:
