Commence at the NE Corner of the SE 1/4 of Section 28, Township 20 South, Range 2 West; thence S.02°35'42"E. along the East line of said 1/4 section, a distance of 99.48 feet; thence S.87'24'18"W., a distance of 1,482.05 feet to the POINT OF BEGINNING; thence N.80°33'12"W., a distance of 50.00 feet to the point of curve of a non tangent curve to the right, having a radius of 25.00 feet, a central angle of 90°00'00" and subtended by a chord which bears S54°26'48"W, a chord distance of 35.36 feet; thence southwesterly along said curve an arc distance of 39.27 feet; thence S.09'26'48"W., a distance of 50.00 feet to the point of curve of a non tangent curve to the right, having a radius of 25.00 feet, a central angle of 90°00'00" and subtended by a chord which bears \$35°33'12"E, a chord distance of 35.36 feet; thence southeasterly along said curve, an arc distance of 39.27 feet; thence 5.09°26'48"W., a distance of 83.94 feet to the point of curve to the right, having a radius of 475.00 feet, a central angle of 06°38'27" and subtended by a chord which bears S12°46'02"W. a chord distance of 55.02 feet; thence southwesterly along said curve, an arc distance of 55.06 feet to a point of reverse curve to the left having a radius of 825.00 feet, a central angle of 05'47'46" and subtended by a chord which bears S13'11'22"W, a chord distance of 83.42 feet; thence southerly along said curve, an arc distance of 83.46 feet; thence N.45'08'37"W., a distance of 188.23 feet; thence N.79'02'38"W., a distance of 203.70 feet; thence N.64'34'50"W., a distance of 180.27 feet; thence N.39"18'10"W., a distance of 83.26 feet; thence N.29'59'17"E., a distance of 83.99 feet; thence N.58'27'57"E., a distance of 77.69 feet to the point of curve of a non tangent curve to the right, having a radius of 275.00 feet, a central angle of 12'45'13" and subtended by a chord which bears N48'25'37"W. a chord distance of 61.09 feet; thence northwesterly along said curve, an arc distance of 61.21 feet; thence N.47°56'59"E., a distance of 50.00 feet to the point of curve of a non tangent curve to the left, having a radius of 225.00 feet, a central angle of 19°26'16" and subtended by a chord which bears S51'46'09"E, a chord distance of 75.97 feet; thence southeasterly along said curve, an arc distance of 76.33 feet; thence S.61°29'17"E., a distance of 89.76 feet; thence N.32'26'02"E., a distance of 128.05 feet; thence S.80'33'12"E., a distance of 332.63 feet; thence N.09°26'48"E., a distance of 5.66 feet; thence 5.80'33'12"E., a distance of 50.00 feet to the point of curve of a non tangent curve to the left, having a radius of 25.00 feet, a central angle of 89°52'21" and subtended by a chord which bears S35'29'22"E, a chord distance of 35.32 feet; thence southeasterly along said curve, an arc distance of 39.21 feet; thence S.0919'10"W., a distance of 50.00 feet to the point of curve of a non tangent curve to the left, having a radius of 25.00 feet, a central angle of 90°07'39" and subtended by a chord which bears S54°30'38"W, a chord distance of 35.39 feet; thence southwesterly along said curve, an arc distance of 39.33 feet; thence 5.09'26'48"W., a distance of 55.66 feet to the POINT OF BEGINNING. Containing 4.5 acres, more or less.
