

AMENDMENT TO REAL ESTATE MORTGAGE AND SECURITY AGREEMENT

This Amendment (the "Amendment") is made and entered into on NOVEMBER 17, 2004, by and between JIMMIE PARKER CUSTOM HOMES, INC, THIS AMENDMENT IS TO ALSO CORRECT THE FORMER FILING AS LLC VS INC (hereinafter called the "Mortgagor", whether one or more) and First Commercial Bank (hereinafter called the "Mortgagee").

RECITALS

A. JIMMIE PARKER CUSTOM HOMES INC (hereinafter called the "Borrower", whether one or more) has (have) entered into as agreement entitled "First Commercial Bank Real Estate Mortgage and Security Agreement", executed by the Borrower in favor of the Mortgagee dated JULY 8, 2004 (the "Credit Agreement"). This Credit Agreement is in the amount of TWO HUNDRED FORTY THOUSAND DOLLARS AND ZERO CENTS Dollars (\$240,000.00).

D. The Mortgagee has required, as a condition to approving the request for the Amended Mortgage, that the Mortgagor enter into this Amendment.


Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
