

All powers granted to the Attorney-in-Fact named hereinabove shall be exercisable by DAVID W. COX notwithstanding the subsequent disability, incompetency or incapacity of the undersigned principals of the Company. All of the rights, powers and authority granted to my said Attorney-in-Fact shall remain in full force and effect unless the Company gives notice in writing that such rights, powers and authority are terminated, which termination notice shall be recorded in the Probate Office of Shelby County, Alabama. Such termination shall not be effective as to any parties relying in good faith on this Special Power of

Attorney unless and until such termination is recorded in the Probate Office of Shelby County, Alabama.
