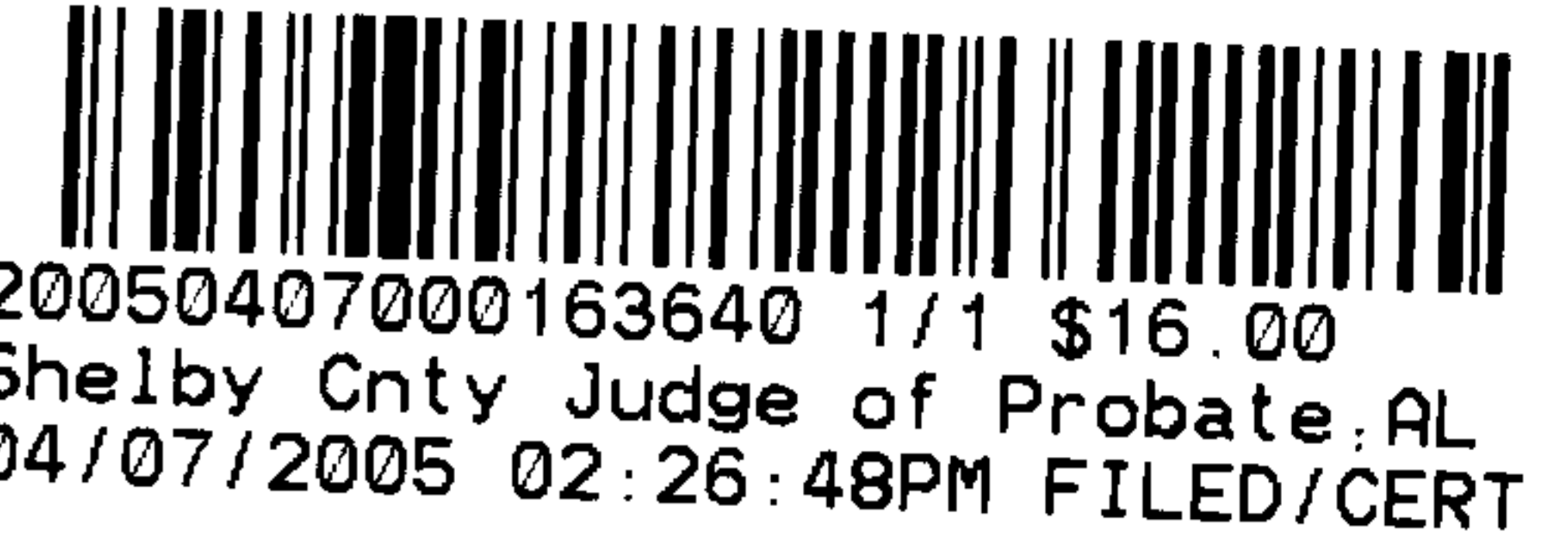

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of \$10.00 in hand paid to Donald E. Sisk, individually and as the only child of Stanley W. Sisk, deceased, Reta B. Sisk and Christine M. Sisk, as the widow of Stanley W. Sisk, deceased ("Grantors") by Donald E. Sisk and spouse, Reta B. Sisk ("Grantees"), the receipt and sufficiency of which are hereby acknowledged, Grantors do hereby grant, bargain, sell and convey unto Grantees, subject to the matters hereinafter set forth, the following described real estate situated in Shelby County, Alabama, to-wit:

Commence at the Northeast corner of the SE 1/4 of the NE 1/4 of Section 2, Township 20 South, Range 2 West; thence run Southwardly along the East line of said 1/4 1/4 for a distance of 2001.16 feet to the point of beginning, said point being on the Southeastly right of way of Shelby County Highway No. 11; thence continue along the last described course for a distance of 531.90 feet; thence turn an angle to the right of 109 deg. 38 min. 07 sec. for a distance of 273.49 feet to the Southeasterly right of way line of said County Highway; thence turn an angle to the right of 99 deg. 43 min. 03 sec. and run along said right of way for a distance of 403.94 feet; thence turn an angle to the right of 4 deg. 46 min. 14 sec. and continue along said right of way for a distance of 106.21 feet to the point of beginning; being situated in Shelby County, Alabama.
