

## ARTICLES OF INCORPORATION OF MODULAR MANUFACTURING INTERNATIONAL, INC.

The undersigned, acting as Incorporator of MODULAR MANUFACTURING INTERNATIONAL, INC., an Alabama corporation (the "Corporation") under the Alabama Business Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation:

<u>ARTICLE I</u> The name of the Corporation is MODULAR MANUFACTURING INTERNATIONAL, INC.

ARTICLE II The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama.

ARTICLE III The Corporation is authorized to issue One Hundred Thousand (100,000) shares of Common Stock.


