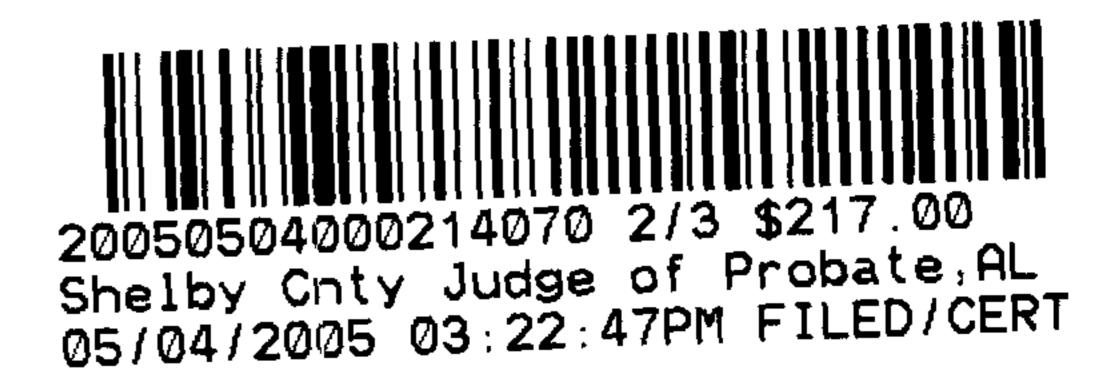
SUBJECT TO:

THENCE NORTH 89 DEGREES 48 MINUTES 23 SECONDS WEST, A DISTANCE OF 234.97 FEET; THENCE NORTH 04 DEGREES 37 MINUTES 59 SECONDS EAST, A DISTANCE OF 478.04 FEET TO A POINT ON THE SOUTHERLY R.O.W. LINE OF ALABAMA HIGHWAY #70, 115 FOOT R.O.W., SAID POINT ALSO BEING THE BEGINNING OF A NON TANGENT CURVE TO THE RIGHT HAVING A RADIUS OF 1,592.11 FEET, A CENTRAL ANGLE OF 04 DEGREES 33 MINUTES 10 SECONDS. AND SUBTENDED BY A CHORD WHICH BEARS NORTH 76 DEGREES 04 MINUTES 05 SECONDS EAST, AND A CHORD DISTANCE OF 126.48 FEET; THENCE ALONG THE ARC OF SAID CURVE AND SAID R.O.W.
