QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of Ten and No/100 Dollars (\$10.00), and other good and valuable considerations, in hand paid to **ABC-NACO INC.**, a Delaware corporation (f/k/a ABC Rail Products Corporation) (hereinafter called "GRANTOR"), the receipt whereof is hereby acknowledged, GRANTOR hereby RELEASES, QUIT CLAIMS, GRANTS, SELLS, AND CONVEYS to **MERIDIAN RAIL CALERA CORP.**, a Delaware corporation (hereinafter called "GRANTEE"), all the GRANTOR's right, title, interest and claim, if any, in and to the following described real estate situated in Shelby County, Alabama, *to-wit*:

Commencing at a point of intersection of the East side of a public road and North side of the Southern Railroad Main Line right-of-way, 100 feet wide, being the Southwesterly corner of the Abex Corporation Wheel Plant Property; thence along the North side line of the Railroad right-of-way, North 65 degrees 26 minutes East a distance of 1005.62 feet to the point of beginning of the parcel being conveyed; continuing along the North side of the Railroad right-of-way, North 65 degrees 26 minutes East a distance of 1200.00 feet to a point; thence North 24 degrees 34 minutes West a distance of 255.00 feet to a point being the Northeast Corner of the formerly recorded Woodbine Avenue 80.00 feet wide which is now closed; thence by the North side of former Woodbine Avenue South 65 degrees 26 minutes West a distance of 700.00 feet to a point; thence North 24 degrees 34 minutes West a distance of 125.00 feet to a point; thence South 65 degrees 26 minutes West a distance of 500.00 feet to a point; thence South 24 degrees 34 minutes East a distance of 380.00 feet to the point of beginning; being situated in Shelby County, Alabama.

TO HAVE AND TO HOLD unto the GRANTEE, its successors and assigns, forever.

The above-described real property was intended to have been included in, and was supposed to have been conveyed by GRANTOR to GRANTEE in, that certain "Statutory Warranty Deed (Corporation)" executed by GRANTOR in favor of GRANTEE, dated January 2002, filed for record in the office of the Judge of Probate of Shelby County, Alabama, on February 7, 2002, and there recorded as Instrument # 2002-06456 (the "Initial Conveyance"). By inadvertence and mistake, the above-described real property was excepted from the Initial Conveyance. This instrument is being executed in order to correct the inadvertent omission of the above-described real property from the Initial Conveyance. The above-described real property is being

conveyed by this instrument pursuant to the same authorization as given for the Initial Conveyance by the United States Bankruptcy Court for the Northern District of Illinois, Case No. 01 B 36484, entitled *In Re: ABC-NACO, Inc., et al.*, Debtors.

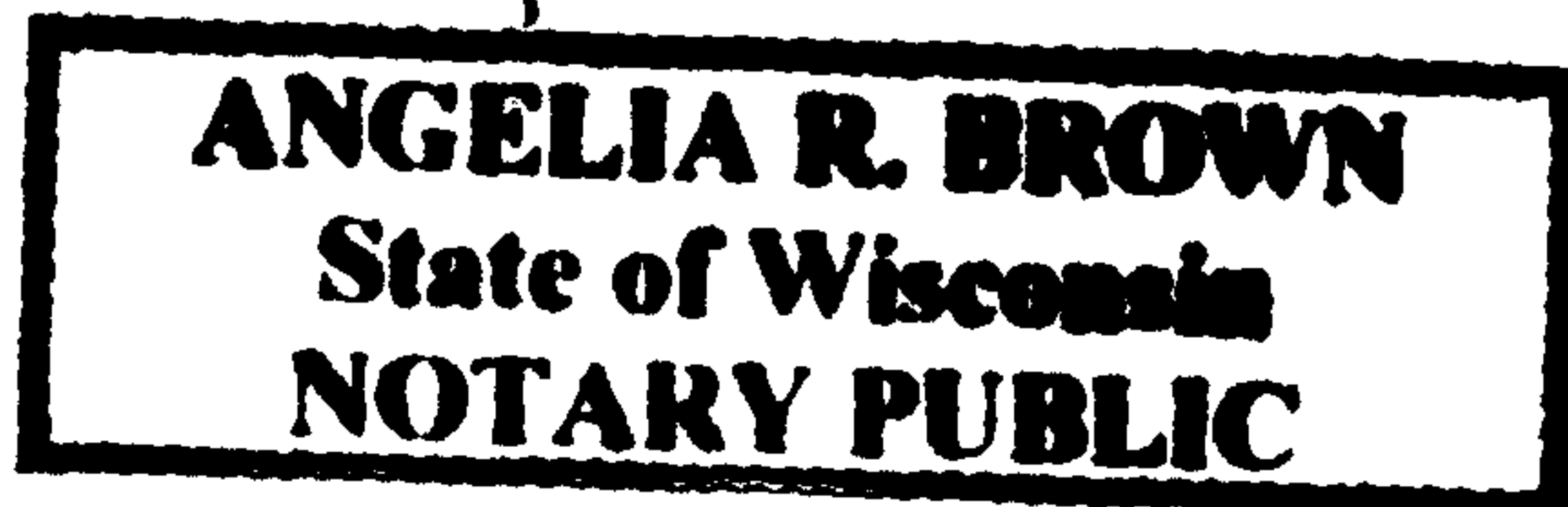
