

Step 1: Contact the Office of the Secretary of State at (334)242-5324 to reserve a corporate name. Step 2: To incorporate, file the original, two copies of the Articles of Incorporation and the certificate of name RESERVATION IN THE COUNTY WHERE THE CORPORATION'S REGISTERED OFFICE IS LOCATED. THE SECRETARY OF STATE'S FILING FEE IS \$40. PLEASE CONTACT THE JUDGE OF PROBATE TO VERIFY FILING FEES.

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the FOLLOWING ARTICLES OF INCORPORATION.
