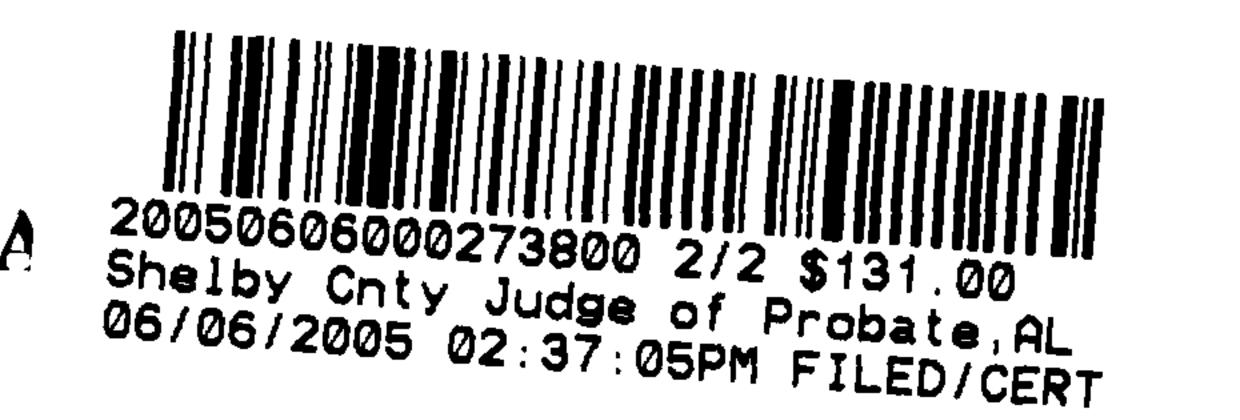

Situated in the Southeast 1/4 of the Northeast 1/4 of Section 3, Township 22 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows: Commence at the Northeast corner of said 1/4-1/4 section, thence westerly along the north line of said 1/4-1/4 section 668.80 feet; thence 91 degrees 19' 21" left a distance of 167.76 feet to the point of beginning; thence continue along last stated course 395.00 feet; thence 90 deg. left, 220.41 feet; thence 89 deg. 57' 56" left 395.00 feet; thence 90 deg. 02' 04" left 220.64 feet to the point of beginning.

ALSO, a parcel of land located in the east 1/2 of the Northeast 1/4 of Section 3, Township 22 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows: Commence at the northeast corner of said section 3, a distance of 448.03 feet; thence 91 deg. 15' 58" left, in a southerly direction a distance of 1681.71 feet to the point of beginning, thence continue along last described course a distance of 631.15 feet to a point on the northwest right of way line of Shelby County Highway No. 22; thence 119 deg. 34' 09" left in a northeasterly direction along said right of way a distance of 97.16 feet to the beginning of a curve to the right, said curve having a radius of 2587.17 feet and a central angle of 3 deg. 20' 38", thence along arc of curve in a northeasterly direction along said right of way a distance of 150.99 feet to end of said curve; thence 63 deg. 37' 01" left from tangent of said curve in a northerly direction, a distance of 507.74 feet; thence 88 deg. 06' 51" left in a westerly direction, a distance of 219.47 feet to the point of beginning.

LESS AND EXCEPT a parcel of land located in the east 1/2 of the Northeast 1/4 of Section 3,

Township 22 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows: Commence at the NE corner of said Section 3; thence in a westerly direction, along the north line of said Section 3, a distance of 448.03 feet; thence 91 deg. 15' 58" left in a southerly direction a distance of 2020.01 feet to an existing iron pin being the point of beginning; thence continue along last mentioned course for a distance of 292.65 feet to an existing iron pin being on the northwest right of way line of Shelby County Highway No. 22; thence turn an angle to the left of 119 deg. 34' 09" and run in a northeasterly direction along the northwest right of way line of Shelby County Highway No. 22 for a distance of 97.16 feet; thence turn an angle to the right of 2 deg. 41' 12" and continue in a northeasterly direction along said right of way line for a distance of 149.59 feet to an existing iron pin; thence turn an angle to the left of 62 deg. 37' 35" and run a northerly direction for a distance of 214.82 feet to an existing iron pin; thence turn an angle to the left of 99 deg. 54' 28" and run in a southwesterly direction for a distance of 221.73 feet, more or less, to the point of beginning.

ALSO LESS AND EXCEPT: Part of Section 3, Township 22 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows: From the northeast corner of said section 3, run in a westerly direction along the north line of said Section 3 for a distance of 448.03 feet, thence turn an angle to the left of 91 deg. 15' 58" and run in a southerly direction for a distance of 1806.71 feet to the southwest corner of the David Michael property being the point of beginning; thence continue along last mentioned course for a distance of 213.3 feet; thence turn an angle to the left of 99 degrees 45' and run in a northeasterly direction for a distance of 221.73 feet to an existing iron pin; thence turn an angle to the left of 80 deg. 05' 32" and run in a northerly direction for a distance of 167.97 feet to an existing iron pin being on the southeast corner of the David Michael property; thence turn an angle to the left and run in a westerly direction along the south line of said David Michael property for a distance of 219.13 feet, more or less, to the point of beginning.

ALSO LESS AND EXCEPT: Part of Section 3, Township 22 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows: From the northeast corner of said section 3, run in a westerly direction along the north line of said Section 3 for a distance of 448.03 feet, thence turn an angle to the left of 91 deg. 15' 58" and run in a southerly direction for a distance of 1,681.71 feet, more or less, to the point of beginning; thence continue along last mentioned course for a distance of 125.0 feet; thence turn an angle to the left of 87 degrees 57' and run in an easterly direction for a distance of 219.13 feet, thence turn an angle to the left of 91 deg. 53' 32" and run in a northerly direction for a distance of 125.0 feet; thence turn an angle to the left of 88 deg. 06' 51" and run in a westerly direction for a distance of 219.47 feet, more or less, to the point of beginning.
