Know All Men by These Presents: That in consideration of TWO HUNDRED FOURTEEN THOUSAND AND NO/100 DOLLARS (\$214,000.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, SHELBY HOMEBUILDERS, INC. herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto RUSSELL F. DAVIS AND ANGELA L. DAVIS (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 105, according to the Survey of Final Plat Long Branch Estates, Phase 1, as recorded in Map Book 34, page 66, in the Probate Office of Shelby County, Alabama.

Subject to:

1)Taxes or assessments for the year 2005 and subsequent years not yet due and payable; (2)Mineral and mining rights not owned by the Grantor (3) All easements, restrictions, covenants, and rights of way of record, including but not limited to: (a) Option to purchase and Restrictions or Covenants recorded in Instrument 20041222000697420, in the Probate Office of Shelby County, Alabama. 
