

THIS LOAN MODIFICATION AGREEMENT (the "Agreement"), made this 20th day of July, 2005, by and between James R Bunn & Susan S Bunn Husband and Wife as joint tenants with right of survivor, hereinafter referred to as "Borrower" and New South Federal Savings Bank, Federally Chartered Savings Bank herein after referred to as "Lender", Mortgage Electronic Registration Systems, Inc, amends and supplements (1) the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") (as modified by an Adjustable Rate Rider of the same date), dated March 8, 2004 and granted or assigned to Mortgage Electronic Registration Systems, Inc, as mortgagee of record (solely as nominee for Lender and Lender's successors and assigns, P.O. Box 2026, Flint, Michigan 48501-2026 and recorded in Book 2004, at page(s) 2004 of the Public Records of Shelby County, Alabama and (2) the Note bearing the same date as, and secured by, the Security Instrument, which covers the real and personal property described in the Security Instrument and defined therein as the "Property", located at: Hwy 93, Lot 4, Genery Gap, Helena, Alabama 35080



In consideration of the mutual covenants and agreements, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- 1. As of July 7, 2005 the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$141,000.00 consisting of the amounts loaned to the Borrower by the Lender and any interest capitalized to date.
- 2. The Borrower promises to make monthly payments of principal and interest of U.S. \$1,105.86 beginning September 1, 2005 and continuing thereafter on the same day of each succeeding month until principal and interest and any other charges as described in the Note are paid in full. If on August 1, 2020 (the "Maturity Date"), the Borrower still owes amounts under the Note and the Security Instrument, as amended by the Agreement, the Borrower will pay these amounts in full on the Maturity Date.
- 3. In addition to the amended terms appearing above, the maturity of the construction phase, as described in various loan documents, shall be changed from **December 31**, 2004 to **July 31**, 2005.

NOTHING herein invalidates or shall impair or release any covenants, conditions, agreements, or stipulations in the Note or Security Instrument and the same, except as herein modified, shall continue in full force and effect, and the undersigned further covenants, agreements, conditions and stipulations of the Note and Security Instrument which are not inconsistent herewith.

ALL Lender's rights against all parties, including but not limited to all parties secondarily liable, are hereby reserved.



THIS Agreement shall be binding upon and shall inure to the benefits of heirs, executors, administrators and assigns, or successors and assigns of the respective parties hereto.
