KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 23, 1997, **Farah Khoury, unmarried, Party of the First Part**, executed a certain mortgage to **Pinnacle Bank**, which said mortgage is recorded in Instrument No. 1997-35354, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to Nationsbanc Mortgage Corporation, Party of the Second Part; and Instrument No.: 1997-37690.
