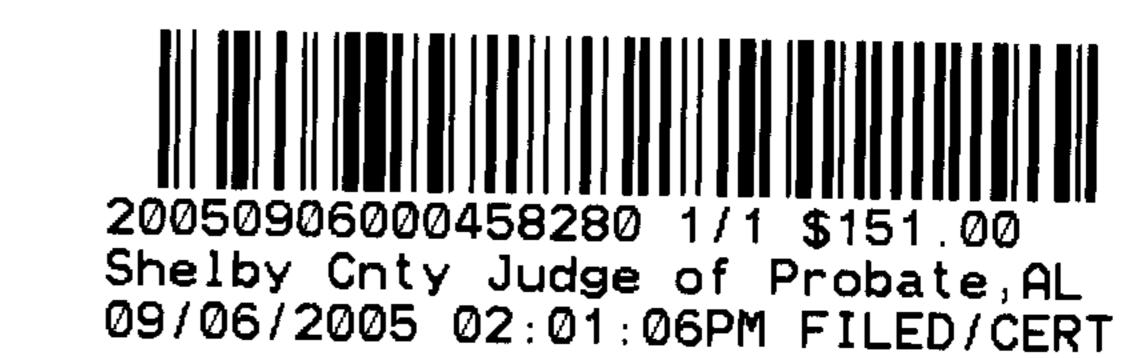
WARRANTY DEED
