This delegation of powers shall commence and be in full force and effect on the date set out herein below and shall remain in full force and effect until said child reaches the age of majority.

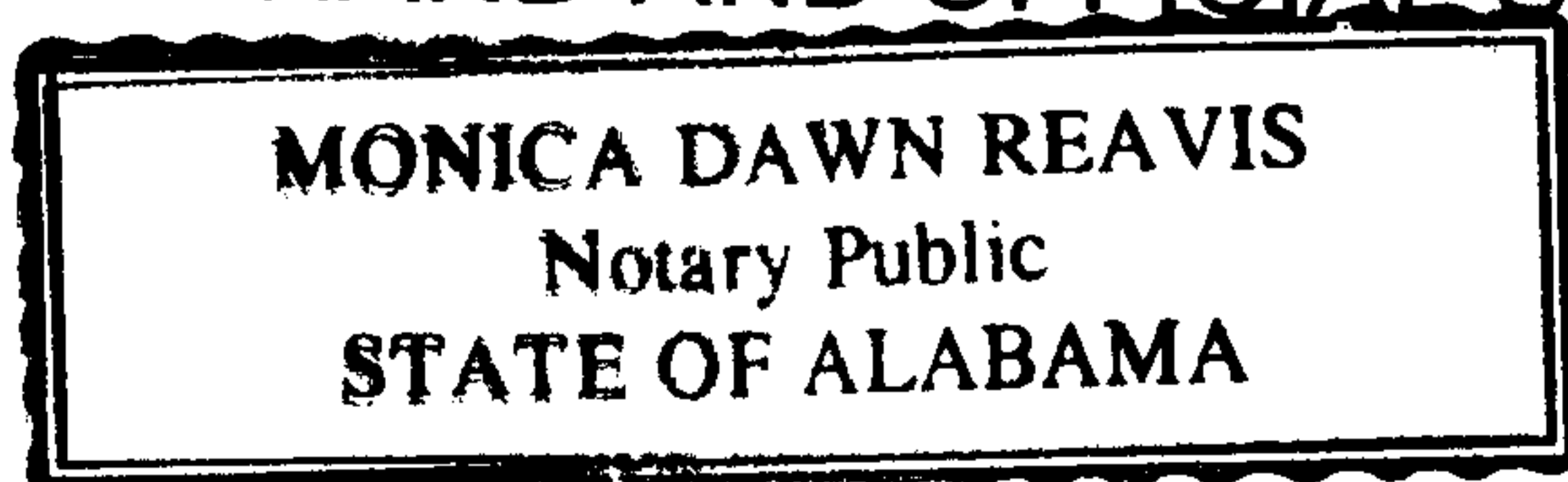
