WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One Hundred Fifty Two Thousand Six Hundred and No/100 Dollars (\$152,600.00), in hand paid to the undersigned, SHOLTO N. BEVIS AND REBECCA H. BEVIS, HUSBAND AND WIFE, (hereinafter referred to as the "Grantor") by JASON P. REDD AND HEATHER L. REDD, (hereinafter referred to as the "Grantee"), the receipt and sufficiency of which is hereby acknowledged, the Grantor does, by these presents, grant, bargain, sell, and convey unto the Grantee as joint tenants with right of survivorship, the following described real estate situated in **SHELBY** County, Alabama, to-wit:

LOT 236, ACCORDING TO THE MAP AND SURVEY OF OLD CAHABA WILLOW RUN SECTOR, FIRST ADDITION AS RECORDED IN MAP BOOK 27, PAGE 15, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

SUBJECT TO:

3. Easements, Encroachments, rights of ways, building set back lines, as shown on recorded plat


(\$102,600.00 of the purchase price was paid from a mortgage loan closed simultaneously with delivery of this deed.)
