### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of July 2004, Lorenzo Harris, Jr., a married man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc solely as nominee for EquiFirst Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040820000466200, and


