

SUBORDINATION AGREEMENT

This Subordination Agreement made as of the 24 day of OCTOBER _____, 2005, by HERITAGE BANKI AKA RENASANT BANK having an address of 600 CENTURY PARK SOUTH, BIRMINGHAM, AL 35226 [Name of original lender], ("Subordinator"), and HERITAGE BANK AKA RENASANT BANK [Name of new lender], a corporation with its principal place of business at 600 CENTURY PARK SOUTH, BIRMINGHAM, AL 35226("Lender").

RECITALS:

- A. PERCY P. CALLEGAN and DANIE'L CALLEGAN [Name of Borrower], of 1113 ASTOR CIRCLE, CHELSEA, AL 35043 ("Borrower"), has applied to Lender for a loan to be made to Borrower and to be evidenced by a promissory note secured by a mortgage covering certain real property.
- B. The real property offered by Borrower as security to Lender is currently subject to the prior lien of the mortgage described below.
- C. Lender will make such loan to Borrower only on the condition precedent that such mortgage be subordinated to the lien of the mortgage described below to be given by Borrower to Lender.

In consideration of the matters described above, and of the mutual benefits and obligations set forth in this agreement, the parties agree as follows:


SUBORDINATION OF EXISTING MORTGAGE
